**Order of Go:** Jump order will be drawn for all team classes. **Captains must declare their preferred rider order three hours prior to the class.** Order of go will be posted at least one hour prior to the class.

**RIDER PARTICIPATION AGREEMENT**

Background. City League International, LLC, a South Carolina limited liability company ("City League"), owns and operates an organized professional equestrian show jumping league doing business as City League International (the "League"). The rider signing this rider participation agreement ("Agreement") below ("Rider") desires to participate in the League and acknowledges that his or her signing this Agreement is a condition to participation.

Rider agrees as follows:

**1. Sporting Rules.** City League publishes rules governing individual competition events City League elects to promote (the "Sporting Rules"), and City League may amend the Sporting Rules at its sole discretion from time to time. Rider confirms that he/she has received and read the current Sporting Rules and agrees to be bound by and comply with the Sporting Rules.

**2. Dangers and Risks; Medical Treatment.** RIDER IS AWARE THAT HIS/HER PARTICIPATION IN A HORSE SHOW, JUMPING COMPETITION OR OTHER LEAGUE EVENT INVOLVES A NUMBER OF DANGERS AND RISKS, INCLUDING THE RISK OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE AND INJURY TO HORSES. Rider is voluntarily participating in League events with a full understanding of those dangers and risks. Rider accepts and assumes those dangers and risks. Rider verifies that Rider is physically fit and has the skill level required to participate in League events safely. Although Rider is responsible for obtaining his/her own medical treatment and City League is not required to provide any medical services to Rider, Rider authorizes City League to obtain medical treatment for Rider if the need arises in connection with a League event.

**3. Release.** Rider releases all of the City League Parties (defined below) from all personal injuries, property damage, medical treatment costs, liabilities, damages, claims, costs and attorneys' fees and expenses of any nature arising out of or relating to Rider's attendance at, or participation in, any horse show, jumping event or other League event (collectively, "Damages"). Additionally, Rider agrees not to sue any City League Party with respect to any Damages. For the purposes of this Agreement, the "City League Parties" are City League and all League sponsors and all of their respective parent companies, subsidiaries, affiliates, officers, directors, managers, members, shareholders, employees, agents and volunteers.

Rider has read and understands this Agreement and voluntarily signs this Agreement.
